Job Summary: The Managing Director of Affordable Housing will lead Walton Communities' Low Income Housing Tax Credit ("LIHTC") and affordable housing business. Walton's current affordable housing portfolio consists of 16 communities and over 2,400 units located around metro Atlanta, Gainesville, and Augusta. In addition to overseeing our current portfolio, the leader of the business will compete for 9% LITCH deals, year 15 resyndication within Walton current portfolio, and seek opportunities for 4% LIHTC deals.

The role will lead the efforts in creating Walton's immediate and long-term strategic vision for affordable housing. This role will be responsible for structuring of LIHTC deals, negotiating deal structures with investors, banks, attorneys, and PHAs, along with overseeing the legal and all other aspects of closing. The Managing Director of Affordable Housing will lead Walton's interactions with local housing authorities (PHAs), the Department of Community Affairs (DCA), the Georgia Affordable Housing Coalition (GAHC), and other interest groups in directing and setting affordable housing policy both locally and nationally. The role will evaluate and oversee the financial underwriting of potential deals. Requirements include coordinating and aligning site selection, DCA policy, financial prudence, execution of deals, and implementing strategy for affordable housing will interface with development and construction personnel, property management, and LIHTC compliance to ensure timeliness in meeting and coordinating deadlines. The role will interface extensively with all Walton Communities Partners.

Responsibilities:

Lead and oversee all aspect of the LIHTC life cycle including forming new PHA relationships, RFPs, application, closings, compliance, and year 15 resyndications.

LIHTC Applications and other RFPs

- Manage a pipeline of land for new development and future development projects.
- Partnering with the development team in determining sites under consideration; including financial and competitive scoring analysis
- Work directly with the Senior Project Manager in the coordination and assembly of LIHTC applications both 9% and 4% deals

LIHTC Underwriting and Closings

- Manage and oversee the due diligence process and initial deal structuring
- Manage the preparation of proformas, financial projections, and evaluation of financing terms
- Ensure legal documents align with current deal terms and underwriting and are consistent with previous operating and partnership agreements
- Manage relationships with lenders, attorneys, architects, brokers, and Partners.

- Manage, create and delegate processes allowing the company to expand its product base
- Strategically manage Walton's affordable housing business and communicate vision and long-term strategy to the Partners

- Explore new affordable housing opportunities in acquisition/rehab, a pipeline of year 15 recaps and QCP, 4% bond deals
- Lead Walton's state tax credit syndication business
