**Position:** Senior Financial Analyst

Job Summary: The Senior Financial Analyst will provide supporting analysis and projections needed for debt and equity financing by gathering and examining financial data and key financial benchmarks: interpreting trends, forecasts, financial results, and developing recommendations for optimum financial performance. The position will also be responsible for executing Walton's strategic and daily management of the financial underwriting performance and financial operations related to all aspects of Walton's business (development, construction, renovations, market rate, 4% and 9% Low Income Tax Credits (LIHTC)). The Senior Financial Analyst will interface with Walton's lenders, third party investors, and Walton Principals. The position will provide leadership internally and externally within our markets to promote Walton's mission of "Creating Neighborhoods that Matter".
